



I : Applicant Eligibility

Applicants must meet the *MOE Regulations Regarding International Students Undertaking Studies in Taiwan*. (For article content, please see the appendix on p.64)

Eligibility Criteria for the above-mentioned application:

1.For admission to Bachelor Programs: High School diploma.

2.For admission to Master's Programs: Bachelor's degree.

3.For admission to Doctoral Programs: Master's degree.

*Due to the different education system in each country, an applicant who will graduate at the same year as the admission to National Taiwan Normal University must ensure to receive his/her diploma and academic transcript of the highest academic degree by the following deadlines (Applicants applying with diplomas or degree certificates from China are required to have the documents notarized by relevant authorities.). Only applicants who can strictly follow this requirement are qualified to apply. FALL semester: Deadline: August 31, 2018 SPRING semester: Deadline: January 31, 2019

Note 1

According to Article 2 of the Nationality Law, a person who meets one of the following requirements acquires the nationality of the Republic of China:

A person whose father or mother was, at the time of his/her birth, a citizen of the Republic of China.*

A person born after the death of his/her father or mother, and whose parent was, at the time of death, a citizen of the Republic of China. *

A person born in the territory of the Republic of China and whose parents are both unknown or are stateless.

4 A naturalized citizen.

* An individual born on or before February 9th, 1980 needs only consider the nationality of his or her father.

Note 2

As stated in the *Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan*, "Overseas Chinese Students that have graduated, been expelled, or suspended from their studies for longer than the maximum allowable duration will lose their status as an Overseas Chinese Student. (...) Students whose status has been temporarily suspended will resume their status upon returning to school." Anyone meeting one of the following requirements is considered Overseas Chinese, and therefore is disqualified for applying as an International Student:

Anyone having previously studied at the Division of Preparatory Programs for Overseas Chinese Students at National Taiwan Normal University (formerly known as 'National University of Preparatory School for Overseas Chinese Students').

- Anyone having applied for studies or previously studied in any school in Taiwan as an Overseas Chinese.
- ③Anyone having taken the university entrance exam for Overseas Chinese students held by the 'University Entrance Committee For Overseas Chinese Student', has filled out the choices of university/college and has been admitted to one of the universities/colleges.

*If the applicant is of foreign nationality as specified in Article 2 under the *MOE Regulations Regarding International Students Undertaking Studies in Taiwan* and possesses (or has possessed) nationality status from the Republic of China (R.O.C.), additional proof is required, such as entry and departure records for the past 6 years, a declaration form stating that they do not hold a R.O.C. household registration (see attachment III, p.75), Certificate of Nationality Renouncement of Republic of China or other proof of documents.

*Applicants applying with diplomas or degree certificates from China are required to have the documents notarized by relevant authorities. If authentication can not be completed by the application deadline, please submit degree certificate, complete transcript and a signed Deposition of Admission Documents (as in attachment V, p.79).

*Eligible applicants who graduate at the same year as the admission to National Taiwan Normal University must submit transcripts for each academic semester and the 'Deposition of Admission Documents for National Taiwan Normal University International Applicants' (as in attachment V, p.79), and are not required to submit the diploma during application. The diploma and transcripts for each academic semester must be submitted upon registration (Diplomas or degree certificates from China are required to have the documents notarized by relevant authorities.); otherwise, the applicants admitted to NTNU will have their admission revoked.

*NTNU holds the right to request applicants to have their degree certificate or diploma authenticated by the ROC diplomatic missions should NTNU find any problem in the applicants' documents.

③A financial statement; a minimum of NTD 100,000 (or USD 3,000) is required. Please select one of the following ways of submission:

①An official financial statement issued within the past three months from a financial institution.

(2)If the financial statement provided is not under the name of the applicant, a financial guarantee is also required from the sponsor (see attachment IV, p.77).

5.Miscellaneous

- This admission prospectus operates under the MOE Regulations Regarding International Students Undertaking Studies in Taiwan. Documents and relevant regulations will be subject to the most updated MOE Regulations Regarding International Students Undertaking Studies in Taiwan.
- 2 International students admitted to NTNU will have their admission revoked and be dismissed from NTNU if any following semesters are violated:

()Violation of the MOE Regulations Regarding International Students Undertaking Studies in Taiwan.

- ②Any NTNU student who is currently studying (including those who suspend their studies) or whose admission status is extended may not apply for admission to the same program of study in the same department/institute. Once the case is verified, the admission of the international student admitted to NTNU shall be revoked, and the vacancy thus created will be filled in the order of the names as they appear on the waiting list
- ③Applicants must take any written exams, interviews, and/or technical tests required by the department or institute to which they are applying. A passport or other form of picture identification must be presented at the test.
- Except for academic credentials earned at overseas Taiwan schools, academic credentials shall be subject to the Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education.
- High school graduates whose qualifications are equivalent to Taiwan's high-school grade 5 may apply for undergraduate programs. However, admitted students shall complete at least 12 extra credits before graduation in accordance with relevant NTNU rules and regulations.

6 Incomplete application may be deemed as invalid. In such cases, applicants must bear the full responsibilities.

Applicants applying for 2 programs or more should submit their application separately to each department/graduate institute.

Students should possess basic skills in Chinese or English. When required by the related department or graduate institute, applicants must take the Test of Chinese as a Foreign Language (held by Steering Committee for the Test of Proficiency-Huayu). Those who fail to pass the proficiency level set by their department/graduate institute shall be required to take Chinese language courses as necessary.

Applications Procedure

- Please ensure that the email address and contact phone number provided in the application system are correct. Applicants may be contacted when needed. If applicants fail to reply within the time given, they will be forfeiting their own rights.
- OAfter documents are submitted, please go to the registration website at http://ap.itc.ntnu.edu.tw/istudent/apply/ to check documents submission status. If the status show "not reviewed" or "not received," please enquire by email at intlntnu@ntnu.edu.tw.
- Students who have completed the application process are not allowed to change the programs.
- Students admitted to NTNU must fulfill the language requirement set by the department/graduate institute of their study as part of the graduation requirements.
- Students admitted to bachelor programs must take the course of "Service Learning" as ruled as part of the graduation requirements.
- If any application materials are found at any time to contain inaccurate, false, or fraudulent information, inauthentic documents or do not meet admission requirements, the student in question shall have their admission to NTNU revoked and be dismissed from the university. Students who have already graduated will have their diploma revoked.

V: Rules governing admission

- 1. The final list of admitted students will be decided by the Admissions Committee. A number of candidates may be put on the waiting list in case any admitted students fail to complete registration procedures.
- 2.Individual departments/institutes may choose not to admit students to their full capacity. In such a case, no waitlisted candidates will be admitted.

2.Admitted students will receive notification through registered mail. Standby pool applicants and unsuccessful applicants will be notified of the admission decision by email without additional regular mail. Applicants must check their admission decisions online and ensure the email address provided in the application is valid.

VII : Registration

- 1.Admitted students are required to submit the New Student Confirmation Form to the Admissions Committee online before the appropriate deadline. The web address for online confirmation form will be noted in the Admission notification. Students failing to complete the New Student Confirmation Form will be regarded as having voluntarily forfeited their admission status. Vacancies resulting from students who have forfeited their admission status will be filled in the order of the names as they appear on the waiting list. Students wishing to retain their position on the waiting list must complete the "Waiting list confirmation" procedure online before the deadline as outlined in the notification letter or waiting list eligibility will be forfeit. Students on the waiting list who are admitted to the university will receive an additional notification letter and need to complete registration procedures before the closing date for registration, which is the first day of class of the current academic year as specified by the annual school calendar. Students who fail to register by the closing date forfeit their admission to the university.
- 2.Admitted students who have completed the online New Student Confirmation Form must complete all registration and enrollment process before class sign-up deadline, including application for admission deferral or suspend admission to avoid having their admission status revokes in accordance with the Admission notification regulations for confirmation and registry procedures. Those who apply with diplomas or degree certificates from China have not had

their documents notarized by relevant authorities by the application deadline must present the notarized documents to the Office of International Affairs within one month of admission results being announced, or the student's admission status will be revoked. Applicants graduating at the end of the current academic year must have their documents reviewed by the Office of International Affairs before registration or the student's of admission status will be revoked.

- 3.According to the MOE Regulations Regarding International Students Undertaking Studies in Taiwan, admitted students must provide proof of medical and personal accidental insurance from their home country valid from entrying into the ROC and up to at least six months upon enrollment in accordance or purchase the six-month medical and accidental insurance coverage through NTNU. Students already insured by the ROC's national health insurance must also provide proof of insurance. If the proof of insurance is issued outside of Taiwan, it should be verified by ROC diplomatic missions in the country where the document is issued.
- 4.Admitted students who are unable to register by the registration deadline and would like to extend their admission status to the following academic year must apply for the extension with Division of Registry, Division of Graduate Studies under the Office of Academic Affairs at the main campus, or Joint Services Office of Gongguan campus before the first day of class of the original semester in which the student was to commence their studies. Please note that not all departments/graduate institutes allow the extension of admission status. (Please refer to respective remarks of the department/graduate institute in this prospectus.) Students whose application for admission status extension are approved by the university may begin procedures for entering the university the following academic year in accordance with the rules and regulations that apply to all new students for that year.
- 5.When required by the department/graduate institute, admitted students must register with the Steering Committee for the Test of Proficiency-Huayu on their own to take the Test of Chinese as a Foreign Language (TOCFL). The Test is administered in January, March, May, July and November each year in Taiwan. Test takers need to pay for the test. Please visit the website for registration period and more details: http://www.sc-top.org.tw
- 6. Transfer credits from other colleges/universities will be governed by the related regulations of this University.
- 7.Admitted students should enquire R.O.C. missions overseas to see if a certificate of language proficiency test is required for visa application. A lack of required document may lead to failure in obtaining visa for your study at NTNU.
- 8.Obtaining admission permit to NTNU does not guarantee the issuance of a Resident Visa. Obtaining a Resident Visa does not entitle the visa holder to enter the R.O.C. (Taiwan). Visa issuance is an act of sovereignty. According to the "Statute Governing Issuance of R.O.C. Visas in Foreign Passport" and "Enforcement Rules for the Issuance of R.O.C. Visas to Foreign-Passport Holders," the R.O.C. reserves the right not to issue a visa and is under no obligation to disclose the reason. If there is any problem related to Visa issuance, admitted students themselves should contact the R.O.C. diplomatic missions overseas for inquiry.

- 1.For any appeals to the admission result, procedure or experiencing from gender inequality, applicants may submit a written statement to the Office of International Affairs within 15 days of the admissions results announcement. Anonymous appeals shall not be processed.
- 2. Issues not covered in these guidelines are either prescribed in the "Admission Regulations for International Students of NTNU" or left to the discretion of the NTNU Admissions Committee.
- 3.In the event of discrepancies between the Chinese version and the English version of this Prospectus, the Chinese version shall prevail.

| Article 1 | These Regulations are formulated in accordance with the provisions of Paragraph 3 of Article 25 of the University Act, |

| | An individual of foreign nationality, pursuant to the following requirements and who has resided overseas continuously for no less than 6 years is also qualified to apply for admission under this regulation. However, an individual who plans to apply for study at a department of medicine, dentistry or Chinese medicine must have resided overseas continuously for no less than 8 years. |
| | An individual who also is a national of the R.O.C., but does not hold nor has had a household registration in Taiwan. An individual who also was a national of the R.O.C. but has no R.O.C. nationality at the time of their application shall have an annulled status regarding their R.O.C. nationality for no less than 8 years after an annulment of R.O.C. nationality by the Ministry of the Interior. |
| | 3.Regarding individuals mentioned in the preceding 2 subparagraphs, they must not have studied in Taiwan as an overseas Chinese student nor received placement permission during the same year of the application by the University Entrance Committee for Overseas Chinese Students. |

Universities and colleges may admit international students to take up places at their institution available to local students within the approved admission quota for that academic year which remain vacant. The number for admission prescribed in Paragraph 1, do not include international students with a non-degree status. |

The plan mentioned in the preceding Paragraph shall include the establishment of the dedicated units responsible for international students, curriculum with emphasis on Mandarin Chinese and Taiwan culture learning, and measures regarding accommodation for international students. The countries and quota for international student recruitment pertaining to Paragraph 1 may be stipulated by the Ministry after consulting with the Ministry of the Interior and the Ministry of Foreign Affairs, if necessary. |



Map of National Taiwan Normal University (Gongguan Campus) 公館校區配置圖










